

Dear Parents.

This letter is to inform and assure you that your child will have a pleasant and safe experience at Mission Ridge Winter Park.

Our instructors are Nationally Trained and Certified through *CASI** *CSIA** and *CADS**. They are trained to encourage safe and controlled skiing and snowboarding during and after your child's lesson. Throughout the entire day, our staff watches out for those who require additional instruction or just a little encouragement. Every effort is made to ensure that each child progresses to the point where he or she reaches a feeling of accomplishment.

Mission Ridge offers a variety of terrain, from very easy to more difficult. All our slopes are freshly groomed every morning with the most advanced equipment to ensure great conditions for all levels of skiers at all times of the season.

Please review with your child the 'Alpine Responsibility Code' the 'Trail Map' and the 'Levels of Difficulty' rating to best prepare them for a fun, safe day.

At Mission Ridge your child is individually fitted with top quality rental ski and snowboard equipment by certified technicians. They are also provided with a Safety Presentation prior to going out on the snow to review all the safety requirements.

To assist you in preparing your child for a comfortable and enjoyable day we recommend the following:

- Reassure your child that they will be taken care of by friendly, caring people while at the hill.
- Have your child wear layers of clothing that can be easily removed or put on as the weather dictates.
- Proper headwear is a must. A toque and neck tube is suggested. Please no long scarves.
- Gloves should be of a waterproof material and an extra pair is suggested.
- Pants should be loose fitting. Ski pants, wind pants and layers of sweat pants are advised.
- Extra socks to change into when needed is wise, however, wearing two pair of socks is not recommended for skiing.

SKILL CLASSIFICATION

Your child must be classified according to the following descriptions. The classifications must appear on the Parent Consent Form and checked off by the parents/guardians (next page).

NEVER EVER - Your child has never skied or snowboarded before at a resort nor has she/he ever taken formal instruction.

BEGINNER - Your child has skied/snowboarded at a resort before and has taken formal instruction in the sport. Your child can stop and turn with consistent success. Your child can maintain speed and control on a variety of beginner terrain.

INTERMEDIATE - Your child has skied/snowboarded on many separate occasions and has taken formal instruction. Your child is able to maintain speed and control using recognized formal techniques on intermediate and advanced terrain.




SKI AND SNOWBOARD HELMETS MAY PREVENT HEAD INJURIES!

Cadet Activity

Thursday January 2, 2020 – Skiing/Snowboarding Day

Mission Ridge Ski Hill

Parent drop off at hill for 0930 hrs

Parent pick up at hill for 1530 hrs (3:30pm)

This activity is a bonus activity. Cadets must sign up for the event and return all relevant paperwork by the deadline to participate. A \$15 lunch allowance is recommended that cadets attending have

additional funds to see them through the day for food and beverages. The cost of the day is covered in our program but please be sure to clearly fill out all forms for required equipment so that we aren't paying additional costs.

Our day works much like a school trip... Helmets are mandatory and a lesson at the start of the day is required. If parents are wanting to spend the day on the hill, they too can qualify for the group rate but will have to pay for their own participation. (\$41.50/full package or \$28.00/lift pass only)

We will meet at Mission Ridge so cadets and families will have to make their own way there. Late arrivals will impact time on the hill and lesson participation, <u>cadets may have to wait an hour or more</u> to get into the next lesson.

** We will be outside for the duration of the afternoon so please be sure that all cadets are dressed appropriate for the activity... Snow pants, toque, mitts, big warm boots, proper coat, etc.

DEADLINE

Cadets need to return their waivers and the total number planning to attend for their family by Monday December 23, 2019, so that we can arrange to have everything we need in place for the day!

Please be sure to physically present cadets and forms at drop off... We must see and talk with parents before the activity and when they are taking their cadet from the hill. Mission Ridge can be busy. Please help us make sure that the activity is safe and secure for all cadets!

Please ensure you inform 2LT Whalley about both number of participants and whether each will be requiring boarding or skiing rentals or just lift tickets and/or helmets for the day. Means of and Deadline to inform 2LT Whalley is a response to his Facebook post by Dec 23. Please be aware that consent forms must be completed for each cadet participating or they will not be allowed to participate.
